



**CITY OF GARDINER
WINTER SAND BID 2015**

The City of Gardiner is accepting sealed bids for 2500 cubic yards of winter sand. This quantity will be considered an estimate based on previous years usage. The City reserves the right to increase or decrease the quantities as deemed necessary. The delivery of sand will be scheduled with the Public Works Director. Re-supply The City of Gardiner with additional sand as needed throughout the winter with a 48 hour notice.

The winter sand shall meet the following specifications:

Aggregate shall be sand of hard durable sharp grained particles free from vegetative matter, lumps or balls of clay or other deleterious substances. Loads that fail to meet the specifications may be rejected by the City representative. In the event of repeated load rejections The City may cancel the contract in its entirety.

The gradation shall meet the following requirements:

- 3/8 inch 100%
- #4 80-100%
- #50 0-35%
- #200 0-3%

No bid will be accepted unless pit location is stated as part of the bid. An inspection of the pit and/or a sample of the material may be requested before bid award.

The bidder shall guarantee complete volume delivery as directed by Public Works Director before **NOVEMBER 20 2015 at 3PM.** A penalty of \$200.00 per day will be deducted for late delivery for each day or partial thereof until volume is received. All sand must be delivered and dumped from the top of the pile/ramp. NO TRAILER DUMPS.

Payment will be made on a measured truck basis. Each load shall be accompanied by a delivery slip, and those slips shall be signed by a Public Works employee and date of delivery noted.

SEALED Bid proposals clearly marked WINTER SAND BID are due at Gardiner City Hall 6 Church St. WEDNESDAY SEPTEMBER 30 AT 10:00 AM

The City reserves the right to reject any and all bids.
